WHUMC Leadership Structure

Western Hills UMC organizes itself and its lay leadership around two broad areas of responsibility:

- 1) Mission/Ministry
- 2) Management/Administration.
- 1) The Mission/Ministry functions of the church are carried out primarily by the laity and staff, organized around a number of teams, committees, work groups, and others, including but not limited to: United Methodist Women, Prayer Ministries, Discipleship, Hospitality, Care Ministries, Missions, etc.

The leaders of any such ministry area, program staff, and clergy comprise the **Ministry Council**. The primary functions of the Ministry Council are to provide opportunities for sharing, visioning, coordinating, and calendaring the ministries of the church, as well as encouraging the formation of new groups as the mission of the church necessitates. The Ministry Council will meet at least twice/year and the Sr. Pastor will preside.

2) The **Management/Administrative** functions of the church (staff management,

finances, facilities, leadership development) are carried out by a sub-set of laity, along with the pastor, according to a "unified board" structure: the **Leadership Board**.

This Leadership Board shall consist of 12-17 members elected annually by the charge conference with the following members: the pastor, the Lay Leader, the delegate/s to Annual Conference, the Chair of the Leadership Board, as well as at least three

designees for each of the following areas: Staff-Parish Relations. Finance, and Trustees. Designees will be responsible for each respective area, but the board will typically function as a "committee of the whole." The Leadership Board will follow a threevear "class"

rotation of

membership to ensure broad participation. Also, the functions of the Committee on Nominations and Leadership Development will be incorporated in the Leadership Board.

The goal of this structure is to fulfill the church's administrative needs more efficiently while freeing more people for ministry. Your prayers for our leadership are greatly appreciated.

WESTERN HILLS ACADEMY NEWS

Moved to Candidate Status



As reported last month, The Academy is applying for accreditation with the Southern Association of Colleges and Schools. The Report on Readiness visit by a representative from the State Office (Dec. 11, 2015) moved WHA from Applicant to Candidate status. The next milestone is an External Review Team (of about 3 people) to visit the school sometime in 2017.

To prepare for that visit, accreditation activities will include the faculty's taking the Next Steps called for in the Readiness Report. The main focus will be on curriculum development and alignment, problems we are already aware of. The Readiness Report will give us an extra incentive to figure how to strengthen the PK-5 curriculum, making it mesh through the grade levels, making certain that each child can be prepared for the next level.

WESTERN HILLS UNITED METHODIST CHURCH FOUNDATION

In December of 1996, the Foundation was established for the purpose of creating a permanent endowment fund to assist the church. It is operated through a separate non-profit corporation, the directors of which are elected by the Charge Conference. The by-laws of the corporation provide that gifts to the Foundation are to be invested and held permanently, with annual distributions of income to the church in amounts determined by the Foundation board of directors. The amount of such distributions is limited so as to preserve the principal value of the endowment fund.

The Foundation began raising funds for this permanent endowment in 1997. These gifts have come in the form of cash, memorials, honorariums, bequests and the cash value of an insurance policy. All such funds have been deposited with the New Mexico Conference Methodist Foundation in Albuquerque, which Foundation has been merged into the Texas Methodist Foundation (the TMF). Funds held by the TMF are deposited into Wespath Investment Management, a division of the General Board of Pension and Health Benefits. Wespath is the largest faith based investor in the U. S., with over \$21 billion in assets. This account is styled as the Western Hills UMC – General Endowment Fund. As of December 31, 2015, the market value of this fund was \$336,665. Beginning in 2010 and continuing through 2015, a total of \$58,325 of income from this fund has been distributed to the church. Income from this fund in the amount of \$10,368 was distributed to the church in 2015.

In August of 2002, the Foundation received a gift from the estate of Grover Stewart in the amount of \$984,205. This gift came in the form of an IRA account then managed by Merrill Lynch in Austin, TX. The document which designated the Foundation as beneficiary provides that the funds are to be held as a permanent endowment, with the income to be distributed to the church. The donor also specified the purposes for which this income may be used by the church. The funds in this account are now being managed by UBS Financial Services in Austin, Texas. As of December 31, 2015, the total value of this portfolio was \$1,188,119. Beginning in 2003 and continuing through 2015, a total of \$530,729 of income from these funds has been distributed to the church. Income from these accounts in the amount of \$14,615 was distributed to the church in 2015.

In August of 2004, by virtue of two charitable remainder trusts, two permanent endowment funds in the original principal amount of \$495,000 each were established with the NMCM Foundations, now TMF. These endowment funds are known as the Grover C. Stewart, Jr. and Carolyn Ann Stewart Endowment Funds for the benefit of Western Hills United Methodist Church. The Foundation has been designated as the receiving and managing agent for income distributed to the church, which income is to be used in accordance with directions contained in the trust instruments that created the funds. As of December 31, 2015, the market value of these funds was \$1,028,572. Beginning in 2005 and continuing through 2015, a total of \$377,057 of income from these funds has been distributed to the church. Income from these funds in the amount of \$37,223 was distributed to the church in 2015.

The sum of \$62,205 distributed by the Foundation to the church during 2015, from income earned in 2014, was used for the following purposes:




VIEWS FROM THE RIDGE
